

MEMBERSHIP AGREEMENT:

Date of Agreement: This [Membership Type] membership takes effect on [effective date], and shall remain valid until the end of the term, which shall be 12 months from the effective date of the agreement.

Payment: The annual payment membership option (Annual) requires full payment at the time of purchase. The monthly payment membership option (Pay Monthly) requires the first month's dues be paid at the time of purchase, and eleven subsequent monthly payments shall be automatically charged to the member's authorized credit or debit card, until the membership term date. Pay Monthly membership total annual dues (monthly fee amount x 12 months) are owed in full by the member, unless cancelled before the term date (See "Cancellation" below).

Expiration and Auto-Renewal: On the first day following the expiration of this agreement, 1) your membership shall automatically renew for one calendar year, unless you opt out of auto-renewal prior to the auto-renewal date, 2) shall be charged to the debit or credit card you authorized, and 3) shall renew at the same rate and terms as the original agreement, unless new terms have been communicated to you in a timely manner (See "Reserves" below). Auto-renewals shall continue until canceled by you, the member (See "Cancellation" below).

Cancellation: 1) Annual agreements may be cancelled within 3 business days after the effective date, or renewal date, and receive a full refund (see "Refund Policy"), upon written notice to the Customer Programs Manager of your intent to cancel, provided that no member benefits, including merchandise discounts, services discounts, or free services have been used during this time period. 2) a) The auto-renewal option may be declined, without penalty, up to and including the auto-renewal date; b) after the auto-renewal date, such memberships may be cancelled for a full refund given the terms above in part 1. 3) Pay Monthly agreements may be cancelled at any time upon written notice to the Customer Programs Manager, and for a one-time fee, calculated as 50% of the balance of all dues owed from the next unpaid period to the end of the agreement term, to be paid immediately at the time of cancellation. All membership ID cards must be returned to Shoot Smart at the time of cancellation in order for the cancellation to take effect.

Refund Policy: No refunds are available for memberships or relevant services not otherwise outlined in this agreement. Memberships cannot be prorated after the date of purchase. Annual fees, paid fully in advance, and Pay Monthly initial payments, are fully refundable up to 3 business days from the date of purchase or auto-renewal. Pay Monthly memberships are subject to a 50% balance fee if cancelled before the term date, as outlined in "Cancellation" above. Refunds are not available in store, and will be issued within 30 days of cancellation notice. See "Cancellation" above for notice requirements. No cash refunds.



Liberty Family Membership: A Liberty Family Membership can be purchased with a primary Liberty membership, for a spouse or domestic partner, and up to 2 children ages 21 and under, residing in the same household. Liberty Family members share the same benefits as the Primary Liberty member.

Terms & Conditions: 1) Memberships and member benefits have no cash value. 2) Benefits, including discounts, may not be combined with other offers. 3) Membership benefits may only be used for non-commercial purposes, including the purchase of firearms, accessories, or ammunition at discount. 4) "Free Professional Cleaning" means express cleaning of a handgun; "Free Private Lesson" is limited to one-hour private firearm-instruction services, not including consultations. 5) Member retail discounts are applicable on in-stock items only. 6) Special orders for non-stock items, or items not currently stocked on a regular basis, will be priced at cost plus 8.5% (not including tax and shipping, when applicable). 7) The member agrees to comply with all range rules and policies, and local, state, and federal laws concerning firearms. 8) Memberships are not transferable. 9) Advertised annual savings with membership versus non-membership are solely dependent on each individual member's use, and are not guaranteed. 10) Membership rates will serve as the primary lane rental in cases of two or more people on one lane, when one is a member. 11) Guardians over 21 years of age are required to purchase memberships for persons under the age of 18 (herein referred to as Youth). 12) Youth members must be accompanied by an adult over 21 in order to use range facilities. 13) Youth members may not handle firearms within the facilities or store without the direct oversight of an accompanying adult over the age of 21. 14) The minimum age for membership is 8 years old. 15) Youth members under 18 may not purchase ammunition or conduct ammunition transactions. 16) Individuals 18 to 21 years old may purchase ammunition for rifle use only.

Reserves: Shoot Smart reserves the right to modify, change, or add policies and rules concerning membership and conduct at any time, without notice, to maintain a safe and family friendly environment for Shoot Smart staff and customers. Shoot Smart also reserves the right to change the price of any membership or service, and any additional packages or benefits, at any time, by written and/or electronic communication, with at least 30 days' notice. Shoot Smart reserves the right to revoke membership status without a refund for breach of terms.
